#### GENERAL INFORMATION

**PRECIP** is formulated to address hydrophobicity and water acceptance in soils during drought periods. **PRECIP** increases the infiltration of water into the soil and improves the length of hydration. **PRECIP** should be applied as a preventative water management strategy.

#### DIRECTIONS FOR USE

Always mix and apply **PRECIP** in accordance with label instructions. Follow the application and mixing guidelines provided in this label.

#### APPLICATION TECHNIQUES

While immediate irrigation is not necessary, watering after the application of **PRECIP** will improve its performance. In situations where tank mix partners achieve maximum efficacy by remaining on the leaf blade, irrigation may be delayed as specified on the tank mix partner's label. During periods of high temperature, all soil surfactants should be watered in to increase performance and safety.

#### USE RATES

##### Spray Application

Apply **PRECIP** at a rate of 2-8 fluid ounces (59-237 mL) in a minimum of 1 gallon (3.79 L) of water per 1,000 ft<sup>2</sup> (92.9 m<sup>2</sup>). Apply **PRECIP** at a rate of 87-349 fluid ounces (5.2 L) in a minimum of 44 gallons (167 L) of water per acre (0.40 ha).

##### Irrigation Injection

Inject **PRECIP** at a rate of 32 ounces (1 L) per acre (0.40 ha).

##### Drench

For ornamental trees, plantings, and container pots dilute 8-16 fluid ounces of **PRECIP** in 100 gallons (0.0625%-0.125% v/v) of water.

##### Seeding and Sprigging

Apply **PRECIP** at a rate of 4 ounces (119 ml) in a minimum of 1 gallon (3.79 L) of water per 1,000 ft<sup>2</sup> (92.9 m<sup>2</sup>) after seeding or sprigging. Irrigate directly after application with a volume of water to sufficiently wet the seeded surface to a 1/2-inch (13 mm) depth. Volume of water needed may vary with soil type.

#### TANK MIXING

Unless prior experience has proven the combination to be effective, compatible and safe on the desired turf species, it is not recommended that **PRECIP** be tank mixed with other pesticides, fertilizers, micronutrients, bio-stimulants or other such products.

#### STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature before use. Store in original container only and do not reuse empty container. Rinse container thoroughly, disposing of rinsate and the container in accordance with federal, state and local regulations. Do not store near heat or open flame.
